- 2. All of the information that is contained in this Application is true and complete, and the Agency understands that this information is material and will be relied upon by Adoption Media, L.L.C. to determine if it should enter into a contract with the Agency.**
- 3. Although the responses provided on this Application will be legally binding on the Agency, this Application does not constitute a contract between the Agency and Adoption Media, L.L.C. If this Application is approved by Adoption Media, L.L.C., it will prepare a formal written Agency Agreement for review and execution by the Agency.**
- 4. If this Application is approved and Adoption Media, L.L.C. and the Agency decide to enter into an Agency Agreement with each other relating to the posting of Profiles on the Photolisting, this Application will be attached to and incorporated as a part of that Agency Agreement.**
